This notice is being delivered to you by **Westpac Banking Corporation** ("**Foreign Dealer**") pursuant to Section 39(2)(b) of the Canadian Multilateral Instrument 93-101 Derivatives: Business Conduct and the national instrument that succeeds MI 93-101 following the adoption of a substantially similar rule to MI 93-101 by the British Columbia Securities Commission (the "**Business Conduct Rule**"). The Foreign Dealer is a foreign derivatives dealer under the Business Conduct Rule and will be relying on the exemption set out in Section 39 of the Business Conduct Rule.

The Foreign Dealer hereby provides notice of the following information:

- (i) The head office or principal place of business of the Foreign Dealer is located in the following foreign jurisdiction: Australia
- (ii) All or substantially all of the assets of the Foreign Dealer may be situated outside of any Canadian local jurisdiction.
- (iii) There may be difficulty enforcing legal rights against the Foreign Dealer because of the above.
